William Schroeder, attorney for the Warren County Agricultural Society, was present along with Agricultural Society Board members, for a work session to discuss the barn fire that occurred over the weekend that claimed the life of two gentlemen and 45 horses along with horse tack and racing equipment.

The Board offered their condolences to family members of the deceased that were present in the audience as well as those present who list their livelihoods when their horses were killed in the fire.

Commissioner Kilburn then suggested the consideration of constructing a bunk house with adequate restrooms and shower facilities for the occasions when it is necessary to tend to horses through the night. There was then discussion relative to the need to meet with other entities relative to what the plan should be relative to rebuilding.

Mr. Schroeder stated that a State Investigation in underway to try to determine the cause of the fire.

Dave Gully, County Administrator, stated that the County insurance will cover the replacement cost of the building and any county owned contents. It will not cover any property lost by anyone else.

Upon discussion, the Board requested that Jake Jones, Building Services Director, be the point of contact between this Board and the Agricultural Society relative to construction.
