Dave McElroy, Soil and Water Conservation District, was present along with Mr. Uetrecht, property owner in Massie Township, to present an application for the creation of an agricultural security area for the 605 acres property owned by Uetrecht Family Farms, Inc. and Dan and Jodi Uetrecht.

Mr. McElroy and Mr. Uetrecht explained what the program does and how it words to the Board and stated the property owners' desire for this land to remain farm land indefinitely.

Mr. Kilburn questioned if the agricultural security area process included any funding by the Federal government.

Mr. Uetrecht stated that the funding for farmland preservation comes from the voter's approving a ballot issue known at "Issue 2", not any Federal dollars.

Commissioner Kilburn stated that he will support this process since it does not include Federal dollars.

Upon discussion, the Board stated their support of this application and stated they will begin the process of creating the area.

The Board approved the appointment of Cynthia L. Comperchio to the Warren County Board of Developmental Disabilities and swore Mrs. Comperchio into office.
