Chris Brausch, Sanitary Engineer, was present along with Jamie Brandenburg, Executive Director of One-Eighty Ministries, and Paul Brothers, property owner in Harveysburg, relative to a request to waiving water and sanitary sewer tap-in fees.

Mr. Brandenburg stated that his ministry is a faith based non-profit organization that feeds the hungry a few evenings a week in the Lebanon Community Center as well as provide clothing, toiletry items and furniture to those in need. He then explained that Mr. Brothers has donated the use of his vacant warehouse to the organization to be utilized for activities that will help generate funds to provide these services. He explained that Mr. Brothers constructed the sanitary sewer line adjacent to this property and requested the Board consider waiving the tap-in fees associated with the services.

Mr. Brausch explained that the tap-in fees will be roughly \$10,000. He stated that the Board has waived fees for schools and other government entities but never for non-profit organizations or churches.

There was discussion relative to a deferred payment plan to allow the ministry to conduct six months of fund raising and then begin paying the tap-in fees on their utility bills spread out over four or five years.

There was also discussion relative to consideration of waiving ½ of the tap-in fee due to Mr. Brothers constructing the sewer line. The Board rationed that if Warren County had constructed the line, he would have received a ½ tap-in fee waiver and been assessed over 20 years on the property taxes.

Upon discussion, the Board stated their desire to allow a six month moratorium on the payments and allow the property owner to begin paying the tap-in fee on their utility bill over the next four or five years. They stated they will take under advisement the consideration of the ½ tap-in fee waiver.
