Commissioner Young updated the Board on the press conference jointly held yesterday with the

County Engineer relative to the Mason Montgomery Road Project.

Bill Becker, Emergency Services Director, was present along with Melissa Abrams and Rick Murray for a work session to discuss the Emergency Management Agency assessment to local jurisdictions.

Mr. Becker explained that the policy established many years ago states that funding for Emergency Management shall be divided as follows:

50% from grants 25% from local political subdivisions 25% from General fund

Mr. Becker then stated that the current assessment on local political subdivisions is \$.16 per resident based upon the most current population figures. He stated that upon investigation of various other Counties throughout Ohio, some county General Funds pay all of the costs, some assess as high as \$.90 per capita. He then stated that Butler County charges \$.39 per capita.

Mr. Becker stated that, based upon the previous determined formula for funding, the current cost to our local political subdivisions should be \$.21 per capita rather than \$.16 with Loveland, Middletown and Monroe portions of Warren County being included as they were not included in the past.

There was discussion relative to the proposed increase which would provide \$10,000 in revenue for Emergency Management from the local jurisdictions rather than General fund.

Upon discussion, the Board determined to continue with the current formula and to provide notice to the local political subdivisions of the proposed cost due to the increase in the per capital fee and the increase in population.

Paul Kindell, Telecommunications Department, was present to discuss the request from the Fire Chief's Association for the approval to purchase a records management system for the EMS portion of the CAD for Patient Care Reporting.

Mr. Kindell explained what this system would do and how it would work. He then stated that the Fire Chief's Association would be paying for the \$100,000 software purchase but Warren County would be responsible for the approximate \$300 per computer for the license and anti-virus software. He stated that there are approximately 20-30 computers.

Upon further discussion, the Board requested that representatives from the Fire Chief's Association contact the Clerk to schedule a work session to further discuss this matter.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:55 a.m. to discuss personnel matters within Juvenile Court pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 11:42 a.m.

Upon motion the meeting was adjourned.
