## **DISCUSSIONS**

Paul Kindell, Telecommunications Director, was present for a work session to update the Board on the meeting he, along with Commissioner Ariss and County Administrator Dave Gully, attended with the Multi Agency Radio Communications System (M.A.R.C.S.) Steering Committee.

Mr. Kindell informed the Board that the Steering Committee has approved our request to connect to their Master Site and presented a timeline of projects as well as the cost overview as of today's date.

Mr. Kindell stated that, as of today, the Warren County/Motorola System contract cost will be \$8,135,750. He stated that the cost to upgrade the Emergency Communications Center is yet to be determined, our cost to upgrade tower sites 8 & 9 is estimated to be \$428,997 and the estimated maintenance of tower sites 8 & 9 is projected to be \$281,825 per year.

Commissioner Young reviewed the following:

- 1. \$1.2 million cost reduction to Warren County due to partnering with the State of Ohio rather than having our own master site.
- 2. Lower maintenance cost to Warren County by approximately \$200,000 per year
- 3. We will have an expanded network due to adding the two tower sites to our system

- 4. Our radios will work throughout the entire State of Ohio
- 5. The State of Ohio is giving Warren County an additional five (5) channels of 800 MHz and therefore, we will not have to mix the 700 MHz channels with the 800 MHz

Commissioner Young thanked Butler County for their offer to partner with them. He stated that we are already committed to the State of Ohio and that partnership is a huge financial benefit to us.

Commissioner South thanked Paul Kindell for his dedication to saving Warren County taxpayer's money through his creative thinking and in-house knowledge.

Upon further discussion, on motion, the Board directed Mr. Kindell to proceed with the change order with Motorola to delete the Master Site from our agreement and partner with the State of Ohio for use of their Master Site.

Upon motion the meeting was adjourned.
