DISCUSSIONS				

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Commissioner Young acknowledge that the Board executed the deed to transfer the Old Mary Haven property located on SR 63 to the newly formed Mary Klingling Trust which is one of the final step to resolving the pending litigation with the State of Ohio.

Mike Bunner, Emergency Services Director, was present to discuss the July 29, 2012, wind event that occurred in Warren County and throughout the region.

Mr. Bunner stated that the E-911 system went down at 5:15 p.m. along with many other E-911 systems (over 300 in Ohio). He stated the following damages occurred within Warren County:

Winds up to 100 mph 55,000 households/businesses without power 89 trees down 59 poles down 11 pole fires 3 field fires 1 structure fire

Warren County's E-911 calls were routed to the Cleveland Ohio area while our systems were down.

Emergency Services Department reviewed the problems which were observed during the event and has made corrections to policies where it was deemed necessary.

The storm which occurred last week enabled Emergency Services to test the corrected policies and all went as planned.

There was discussion relative to the problems with the E-911 system which were caused by failures of Century Link.

Upon discussion, the Board directed the Clerk to contact Paul Kindell, Telecommunications Director, for a work session to discuss the failures and ways that Warren County can ensure it does not happen again.

On motion, upon unanimous call of the roll, the Board entered into executive session at 9:42 a.m. to discuss personnel pursuant to Ohio Revised Code Section 121.22 (G)(1) and imminent litigation pursuant to Ohio Revised Code Section 121.22 (G)(3) and exited at 11:20 a.m.

Upon motion the meeting was adjourned.
