Art Hardin, Warren County Representative to the ODNR Caesar Creek Marina Committee, provided an update on the progress to date on the marina.

Mr. Hardin stated that ODNR plan which includes beginning construction of Phase 1 as the end of the year. He then stated that the original start date of 2013 was delayed by the Army Corps of Engineers determining the need for an archaeological study prior to construction. The study required the lowering of the lake by ten feet which was completed during the winter of 2013-2014.

Mr. Harden stated that ODNR plans to lower the lake over the winter and begin excavating for the installation of the docks prior to the 2015 boating season.

Mr. Harden stated that Phase 1 includes a fueling station, snack bar and 150-200 boat slips, some with both water and electric service. He then stated that the future design will accommodate 300 boat slips.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:14 a.m. to discussion personnel matters relative to hiring within Emergency Services, Water and Sewer and Children Services pursuant to Ohio Revised Code Section 121.22 (G)(1) and pending litigation to discuss BOCC vs. Marvin Duren, et al and Dan Alesi, et al., v. Warren County Commissioners pursuant to Ohio Revised Code Section 121.22 (G)(3) and exited at 11:18 a.m.
