Members of the Warren County Agricultural Society were present along with a representative from Kleingers & Associates and representatives from the Warren County Regional Planning Commission for a work session to discuss preliminary recommendation for the Warren County Fairgrounds Master Plan.

Greg Orosz, consultant with the Regional Planning Commission, stated the importance that all of the proposed plans do not include nor rely upon the acquisition of any property. He clarified that all the proposals only include property owned by Warren County.

Jay Stewart, Kleingers & Associates (Warren County Agricultural Society consultant), presented the attached preliminary improvement plan on behalf of the Agricultural Society.

Mr. Orosz stated that he and Mr. Stewart have been working closely together and are looking for guidance from the Board of Commissioners on the identification of parcels and outlots.

Martin Russell, Warren County Economic Development Director, stated he would like to utilize the master plan as a marketing tool to present to prospects looking to locate within Warren County. He stated that he has been working with the City of Lebanon on bringing together a unified vision of the property from the County, City and Agricultural Society's perspective.

The Board stated the importance of all three parties being "on the same page" when it comes to future improvements.

Commissioner Young stated the importance of keeping the fair at the current location and making this county owned asset a value to the taxpayers. He then stated the requirement for a new lease agreement to be negotiated with the Warren County Agricultural Society in order to accomplish this redevelopment.

Bruce McGary, Assistant Prosecutor, stated that from the conceptual plan presented by Mr. Stewart, he now can part out the property that would be subject to any new lease agreement and begin that process.

There was discussion relative to the electrical consultant evaluation.

Dave Gully, County Administrator, informed the representatives from the Agricultural Society that he and Commissioner Young and planning a meeting with representatives from the City of Lebanon to discuss the high rates being charged to Warren County properties.

Tiffany Zindel, Deputy County Administrator, was present along with representatives from the Warren County Veterans Administration to discuss the 2015 budget.



Warren County Fairgrounds Improvement Plan

Plan Notes:

The purpose of this Improvement Plan is to identify year round programming activities that will utilize theses public facilities throughout the year to increase revenue opportunities and add to the destination based amenities available in Warren County. This Plan is a first draft towards creating a site layout that provides a large amount of programming flexibility while supporting and enhancing the adjacent commercial development activities proposed for this site.

This improvement Plan is shown at build-out. It is understood that the phasing of such items as fair event parking and construction of improvements will be required.

Pavillon: A new Fair structure is proposed to replace the grandstand. This multi-purpose space would provide a great deal of flexibility to accommodate a wide range of uses and events throughout the year.

Great Lawn: A large green space is proposed to be centrally located adjacent to the new Fair structure to provide for a multi-purpose space to host a variety of events. This green space is intended to provide for a seamless pedestrian access flow between the Great Lawn and the new structure.

Track In-field: This existing space is identified as a prime asset that allows for a wide range of larger scale events and activities. Music concerts and large scale festivals could be accommodated in this space with easy accessibility to the new Fair structure.
