On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Lauren Cavanaugh, Human Services Director, was present for a work session to discuss the following matters:

- 1. Title XX County Profile –Mrs. Cavanaugh reviewed the FY 2016 and FY 2017 County Profile and explained the need for a public hearing to be held by the Human Services Advisory Committee for final approval prior. On motion, upon unanimous call of the roll, the President of the Board signed the Title XX County Profile as attached hereto and made a part hereof.
- 2. RFP—Mrs. Cavanaugh stated her interest in issuing a request for qualifications relative to the coordination of the guardianship program. She stated the increased caseloads and amount of staff time required per case will eventually require the need for additional personnel to administer services.
- 3. Innovation Grants—Mrs. Cavanaugh reviewed the two innovation grants she has applied for from the State of Ohio:
 - a. \$75,000 in PRC type funds for Warren County senior citizens in need
 - b. Funding for technology improvements
- 4. TANF Summer Young Program—Mrs. Cavanaugh stated that they are partnering with OhioMeansJobs Warren County to make a more robust youth jobs program for this summer.

PUBLIC HEARING FY 2015 ANNUAL ACTION PLAN

The public hearing to consider the FY 2015 Annual Action Plan (CDBG Public Hearing #2) was convened this 10th day of March 2015, in the Commissioners' Meeting Room.

Susanne Mason, Program Manager, reviewed the projects chosen by the Board of Commissioners as follows:

Commissioner Young requested any comments from those in attending.

There was no one present to speak relative to the proposed grant application.

Upon further discussion, the Board closed the public hearing and approved and authorized the submission of the Fiscal Year 2015 Warren County Annual Action Plan.

Savannah Shafer, Director of Communications, was present along with Ashley Hatfield, Warren County Data Processing, to present the newly redesigned Warren County website.

Jeff Thomas, Soil and Water Conservation District, was present along with property owners to request the Board's consideration is support of an agricultural easement application being submitted by property owners relative to their farmland located within Warren County.

Mr. Thomas reviewed the acreage and location of the farms.

Commission Young stated his appreciation for the property owners desire to participate in this program and stated his support for the applications.

Upon discussion, the Board resolved (Resolution #15-0371, #15-0372, #15-0373, #15-0374 and #15-0375) to support of the applications of David O'Banion, Dwight Michener, and Shane and Jennifer Dobbs for the Local Agricultural Easement Purchase Program of the Ohio Department of Agriculture (LAEPP).

Kurt Weber, Deputy County Engineer, was present for a work session to discuss the following matters:

1. Roundabout at Fields Ertel and Columbia Road in Deerfield Township—Mr. Weber reviewed the proposed project to construct a roundabout in order to alleviate traffic congestion at this intersection. He then reviewed the need for the purchase of right of way in order to complete this project.

Commissioner Young discussed the property located closest to the proposed roundabout and the possible need to acquire the entire parcel due to location and the amount of road frontage that will be required.

Mr. Weber stated that the project would be a 50/50 project with Hamilton County and is projected to begin construction in late summer of 2016.

Upon discussion, the Board resolved (Resolution #15-0376) to determine the necessity for the certain road improvement project for public use without charge where special assessments are not to be levied or collected, to be known as the Fields-Ertel Road and Columbia Road/Lebanon Road Intersection - Roundabout Improvement in Deerfield Township, Warren County, Ohio.

2. Establish Policy for the Waiving for Property Appraisals for the Acquisition of Right of Way and Highway, Drainage and Temporary Easements for Road and Bridge Projects—Mr. Weber present legislation for the Board to consider relative to the establishment of a policy permitted within the Ohio Revised Code which would allow the waiving of the requirement of an appraisal for the purchase of easements or right of way valued at \$10,000 or less.

The Board discussed the proposed policy and stated their desire to limit the ability to waive the appraisal on properties with an estimated value of \$1000 or less.
