CONTINUATION TO CONSIDER TEXT AMENDMENTS TO THE WARREN COUNTY RURAL ZONING CODE TO AMEND ARTICLE 2 SECTIONS 2.205, 2.611.3, ARTICLE 3 SECTION 3.102, 3.202.3, 3.202.7 AND ARTICLE 4 DEFINITIONS

The continuation of the public hearing to consider text amendments to the Warren County Rural Zoning Code to amend Article 2, Sections 2.205 (Table of Uses), 2.611.3(Uses within the I-71/SR 123 JEDD Overlay District), Article 3 Sections 3.102 (Accessory Uses, Buildings and Structure Standards), Section 3.202.3 (Farm Based Tourism) and Section 3.202.7 (Winery (Non-Exempt Agriculture) was reconvened this 6th day of December 2016, in the Commissioners' Meeting Room.

Michael Yetter, Zoning Supervisor, stated that it is his impression that the consensus is that Distribution Centers will remain as a conditional use but stated his desire to have the added wording in 2.611.3(A) remain as proposed and also make a few changes in the definitions in order to have consistent wording throughout the zoning code.

There was discussion relative to adding Warehouse Depot as a conditional use rather than a permitted use.

The Board stated their desire for Warehouse Depot to remain a permitted use.

Upon further discussion, the Board closed the public hearing and resolved (Resolution #16-1930) to approve a modification to the text amendments to amend Article 2 Sections 2.205, 2.611.3, Article 3 Sections 3.202.3, 3.202.7 and Article 4 Definitions.
