Chris Brausch, Sanitary Engineer, was present for a work session and discussed the following matters:

- 1. Warren County Career Center Fee Waiver Request—The Warren County Career Center is constructing a First Responder training center for the purpose of educating their students on the proper techniques of extinguishing structural fires and has requested the Board consider waiving the tap-in fee and establishing a minimum bill based upon a 5/8 inch residential meeting. Upon discussion, the Board resolved (Resolution #17-0415) to approve the request.
- 2. Waynesville Wastewater Treatment Plant Engineering Contract—Mr. Brausch stated that the Board had selected Jacob Engineering Group upon completion of the interview process from the Request for Qualifications that were issued. He presented the attached PowerPoint presentation outlining the area that the wastewater treatment plant services, the project goals, schedule, and proposed cost of construction. He then reviewed the engineering costs and stated the probability of reducing the expenditure by completing inspections "in house" on the project rather than utilizing Jacobs Engineering Group. Upon further discussion, the Board resolved (Resolution #17-0416) to enter into an engineering agreement with Jacobs Engineering Group for the design of improvements to the Waynesville Wastewater Treatment Plant.

Bruce McGary, Assistant Prosecutor, was present for a work session to discuss the notice received on February 16, 2017, of Turtlecreek Township's creation of a Tax Increment Financing District for the Union Village development in Turtlecreek Township.

Mr. McGary explained that the Board has the option to do nothing, accept or object to the tax increment financing districts proposed for more than ten years or where the percentage of the Improvement exempted from taxation would exceed seventy-five percent (75%). He explained that if the Board objects, they can then negotiate a compensation agreement with Turtlecreek Township.

Upon discussion, the Board resolved (Resolution #17-0417) to formally objects to the number of years of the exemption in excess of ten with respect to each incentive district proposed by the Township, as set forth in the TIF Notice, and approve and enter into a compensation agreement relative to same.






