Gene Steiner, Warren County Agricultural Society, was present along with Rebecca Osborne, Fair Board Secretary, representatives from McGill Smith and Punshon, Inc. (MSP), and Adam Nice, Assistant Prosecutor, for a work session relative to the Warren County Event Center proposed to be constructed at the Warren County Fairgrounds.

Jack Willard, MSP, reviewed the attached PowerPoint presentation relative to the proposed design that includes the following:

Administrative offices
Meeting/conference spaces
Main entrance
Lobby
Covered vehicular drop off
Public restrooms
Covered outdoor seating
Catering kitchen
Main event space
3 break out room

Mr. Willard stated that the main event space will accommodate 300-400 people with round table seating. He stated the ability to open up the facility with folding walls on the break out rooms and with theater style seating with the entire room opened up, the facility would accommodate 1000-1200 people and $50-60\ 10\ x\ 10$ square booths.

Mr. Willard stated that the proposed facility is approximately 10,000 square feet all open and would accommodate 500 people with round table seating. He then stated the proposed design would allow for an additional 5000 square foot addition.

There was discussion relative to the hiring of a construction manager at risk and the process that must be followed pursuant to the law.

Randy Merrill, MSP, discussed the advantages and disadvantages of using a construction manager at risk.

There was discussion relative to the appropriate design based upon what we think the needs are, versus what a market study shows are needed.

Upon discussion, the Board resolved (Resolution #17-0772) to authorize the request for qualifications for construction management at risk services for the Warren County Fairgrounds – Event Center and requested the work session be continued to Tuesday, May 16, 2017, in order for Commissioner Young to have input on the project.






Warren County Fair Grounds Event Center Preliminary Project Review May 11, 2017























Warren County Fair Grounds Event Center Exterior View 1










Warren County Fair Grounds Event Center Interior View 1
