#### **DISCUSSIONS**

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

On motion, bids were closed at 9:00 a.m. this 8<sup>th</sup> day of August and no bids were received, opened and read aloud for Sale of Property located at 315 West Silver Street, Lebanon, Ohio for the Board of Developmental Disabilities.

On motion, bids were closed at 9:15 a.m. this 8<sup>th</sup> day of August and the following bids were received, opened and read aloud for the Chip Seal Project for the Warren County Engineer's Office:

Neil Tunison, Warren County Engineer will review bids for a recommendation at a later date.

Paul Kindell, Telecommunications Director, was present for a work session to follow up on the request of Verizon Wireless to attach an antenna to our Warren County Campus Emergency Communications Tower and to construct a telecommunications tower at our Monroe Road Water Warehouse facility.

Mr. Kindell reviewed the attached update report relative to the lease proposal from Verizon Wireless and also discussed the concern that Senate Bill 331 could become a challenge for all local governments throughout the State of Ohio.

Mr. Kindell discussed the need for an additional telecommunications tower on the Justice Drive campus regardless of any Verizon lease for public safety purposes. He stated that if Verizon leases space upon the new tower, the payback would be approximately eleven years.

Mr. Kindell then discussed the construction of a telecommunications tower on the Monroe Road sight vs. the maximum lease payment Verizon Wireless is willing to pay. He reviewed that the Board had requested a \$3000 per month lease payment vs. the maximum of \$2500 Verizon offered. He then stated the payback would be approximately 14 years at \$2500 per month.

There was discussion relative to our existing microwave antenna that is attached to the water tower on the Monroe Road site. The Board stated they are not willing to construct a new telecommunications tower on Monroe Road but questioned the ability to negotiate the relocation of the microwave antenna from our water tower to a tower construction by Verizon Wireless within a lease agreement.

The Board then stated their agreement to construct a new tower on the Justice Drive campus and to continue negotiations with Verizon Wireless, along with other carriers, to locate upon our new tower.

Neil Tunison, County Engineer, was present for a work session to discuss the bridge over the Little Miami River between Deerfield and Hamilton Township located along King Avenue/Grandin Road.

Mr. Tunison stated that the existing bridge is deteriorating and the existing prestressed box beams cannot be repaired. He then reviewed the following options available to the Board:

<u>Alternative 1.</u> Cul-de-Sac Grandin Road in Hamilton Township and King Avenue in Deerfield Township and remove the existing bridge.

<u>Alternative 2.</u> Rehabilitation of the existing bridge at the exact location without changes to adjacent roadway approaches. Mr. Tunison stated the estimated cost is between \$3.5 - \$4 million with 80% of the cost being paid for with Federal funding with a 20% local match. He stated the life of the bridge utilizing Alternative 2 would not be as long as they would be reusing the base structure that is approximately 30 years old.

Alternative 3. Construction of a new bridge upstream of the existing bridge that would clear span the Little Miami River and improve the safety of the adjacent roadway approaches. The new bridge would provide a grade separated crossing with the Little Miami Scenic Trail and would allow for pedestrian and bike use while remaining at two lanes for traffic. He stated this would eliminate the existing hairpin turn and would cost approximately \$9 million with up to \$5 million being funded by Federal funds.

Mr. Tunison stated that he conducted an open house at the school in Kings Mills and an overwhelming number of residents attended. He stated that the majority of those present prefer Alternative 3.

There was discussion relative to the economic development benefits to Alternative 3 as well as the public convenience.

Mr. Tunison then stated his recommendation for Alternative 3 and stated his ability to fund the local required match of approximately \$4 million through other sources including road and bridge funds.

Upon discussion, the Board commended Mr. Tunison on his ability to prioritize and fund important projects and stated their agreement to proceed with Alterative 3.

Larry Sims, Warren County Sheriff, was present to update the Board on the incident that occurred in Pod B of the Warren County Jail.

Sheriff Sims reviewed the events that occurred on August 1, 2017, and commended the jail staff for their fast, efficient work in avoiding a riot. He then stated that to ensure the safety of his staff, he made the decision that day to reinstall the cell doors on Pod B.

There was discussion relative to the concern of the Board regarding the jail not being in compliance with the Jail Standards with the reinstallation of the cell doors.

Sheriff Sims discussed the jail standards and stated he was in discussion with the State prior to the reinstallation of the doors and their direction was to reinstall the doors if he chooses. He then explained that the jail doors would only be one standard that was not in compliance and as long as 90% of the standards are met, Warren County Jail would remain in compliance with the Ohio Jail Standards. He then stated he is in process of requesting a variance to the jail door standard.

The Board discussed the liability associated with not being 100% in compliance with the Jail Standards.

There was discussion relative to the change in administration at the State of Ohio which resulted in a change in interpretation.

Sheriff Sims stated that the standards have not changed from six years ago when Warren County met all of the standards but the new administration has determined the need for an extra shower in the pod.

Sheriff Sims discussed the changes in policy that have been made in order to maintain the safety of the inmates. He stated he expects to hear from the State in a few weeks on the request for a variance but they have already confirmed that they can reinstall the cell doors and continue to double bund bunk the inmates.

Upon discussion, the Sheriff stated that Warren County will either be out of compliance on the cell door issue or the State will grant the variance.

The Board discussed and ranked the architectural firms that submitted qualifications for the New Warren County Jail Project.

Upon lengthy review and discussion, the Board resolved (Resolution #17-1250) to authorize the Warren County Administrator to initiate negotiations of a professional design services contract with KZF Design to perform the services at a compensation determined to be fair and reasonable

to the Board, as well as considering the other factors required by Section 153.69 (B) of the Ohio Revised Code.

Upon motion the meeting was adjourned.

# Verizon Lease Proposals

# August 8, 2017

#### Monroe Road

If they provide the tower they are proposing \$1500 per month

We provide the tower, \$1900 per month.

Our cost to build estimated at \$319,943.75 Payback @\$1900 is 14 years.

## 500 Justice

We rejected them using the existing tower due to capacity and concerns. We are currently modifying the tower to support an additional dish and reduce twist of existing dishes.

If we build a second tower, their max offer is still \$2500 per month.

Our cost to build estimated at \$245,906.25 Payback @\$2500 is almost 11 years.

We would use the second tower as a redundant microwave path for the Public Safety Radio System and 911.

### SB331

Question exists about Ohio Senate Bill 331

Does SB331 give carriers right to attach to our towers? It seems to.

SB331 sets rate limit to \$200 per year per attachment.

Towers proposed for construction are quoted to support 3 carriers, in this case Verizon +2 additional.
