Jason Woehrle, Granger Construction Company, was present to discussed addenda #7 to the Construction Manager at Risk Services contract for New Jail and Sheriff's Administration Office Project.

Mr. Woehrle explained that due to the time it takes to manufacture the security glass and detention hardware, he is recommending removing this item from the Guaranteed Maximum Price (GMP) and moving forward with this portion in advance through Addendum #7.

Mr. Woehrle explained that it will take approximately three months to manufacture these items and if the Board waits until we have the GMP, it will put the project behind schedule.
