## **DISCUSSIONS**

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Brian Sleeth, Director of Board of Elections, was present along with Ben Clift, Director of Information Technology, and various members of the Board of Elections, to discuss the recent directive from the Ohio Secretary of State which instructs county boards of elections on continuing action and outlines additional requirements that each board must take to enhance its overall election security and protect its information technology (IT) systems.

Mr. Sleeth explained that he and his Board have been in discussions with the County IT Department as to whether they would be able to meet the requirements of the directive in house or would need to issue a Request for Proposals (RFP).

Mr. Clift explained that the voting system itself is on a separate, closed network with no outside connections that would leave it vulnerable to outside influences. He further explained that the Secretary of State's directive requires that all systems within the Board of Elections offices be on dedicated servers with firewalls separate from the County servers.

Mr. Clift stated that currently, the County IT department does not have the staffing or resources necessary to complete the directive's requirements by the deadline. He further stated that issuing

the RFP would give some idea as to what the costs would be and whether it would make more sense to complete the work in-house or contract with an outside agency.

Kenny Henning, Ohio Secretary of State's Office, introduced himself and gave some information on what other Ohio counties are implementing to comply with the directive.

Jeff Monroe, Board of Elections Chair, stated that the Secretary of State's Office has acknowledged the security of the County's current system and is willing to work with the Board of Elections in complying with the directive in the most cost efficient manner.

There was discussion relative to the need to issue the RFP as well as the review and selection process. It was determined that County Auditor Matt Nolan, Brian Sleeth, Ben Clift, and other Board of Elections' board members and staff form an evaluation committee to evaluate and rank the proposals and make recommendations to this Board.

Upon further discussion, the Board resolved (Resolution 19-1059) to issue a Request for Proposal for servers, software, network hardware, installation, configuration, on-going IT maintenance and support for Board of Elections and appointed members to an evaluation committee to review proposals and make a recommendation to this Board.

Upon motion the meeting was adjourned.
