- 1. Request for 3% increase in the contract with the Warren County Humane Association—Mrs. Zindel informed the Board of the request from the Warren County Humane Association for a 3% increase to the service agreement. She provided a history of compensation to the Board and upon discussion, the Board agreed to the increase.
- 2. Airport Authority—Mrs. Zindel discussed the abrogation easement with the property owners adjacent to the Warren County Airport. She informed the Board of the property owner's request to remove the trees within our easement area in lieu of paying to have them trimmed. She then stated that the cost to remove the trees is 90% refundable. Upon further discussion, the Board agreed to fund the cost to remove the trees.
