Sarah Hippensteel-Hall and Mike Eckbeg, Miami Conservancy District Water Stewardship team members, were present to provide an update on the programs and activities of the Miami Conservancy District's Aquifer Preservation Program.

Mr. Eckberg provided background relative to the Water Stewardship Program of the Great Miami River Corridor.

Ms. Hippensteel-Hall presented the attached summary report for 2012-2019.

Chris Brausch, Sanitary Engineer, was present for a work session and discussed the following:

1. Socialville Foster Elevated Water Tower Painting—Mr. Brausch discussed the painting of the water tower on Socialville Foster Road in Deerfield Township. He stated that the Deerfield Township Trustees are requesting to have their logo painted on the tower at their expense.

There was a discussion relative to the need for a discussion relative to any desire that Warren County may have now or in the future to begin our own "branding".

Commissioner Grossmann stated he has no problem with allowing Deerfield Township's logo.

Commissioner Jones stated she would make some inquiries prior to making a final decision on Deerfield Township's request.

Upon discussion, it was determined to continue this discussion at a future date.

2. Butler-Warren Road/Plainview Road Sewer Assessment Project Update—Mr. Brausch informed the Board of his meeting with key residents within the proposed project, discussing the proposed assessment along with contributions from Deerfield Township and Warren County. He stated the need to reconfirm the Board's commitment of \$2000 per home and relayed the request of the homeowners for the Board to consider increasing their contribution.

Commissioner Jones stated she will honor the \$2000 commitment that was made by the previous Board but does not want to increase the contribution.

3. Rural Water System Rules & Regulations—Mr. Brausch discussed the proposed amendments to the Rules and Regulations of the Water and Sewer Department specifying terms and conditions for the extension of small diameter (less than 8") water lines in rural areas. He stated that the proposed regulations include the requirement of a petition that includes a "sign off" acknowledging there will be no fire protection. He then stated the defined rural area is limited to three areas of the county unless the Board approves a modification.

Bruce McGary, Assistant Prosecutor, stated his concern with future homeowners' lack of notification of no fire protection stating there is no way to legally require it.

Upon further discussion, the Board resolved (Resolution #20-0163) to approve a modification to the Rules and Regulations of the Warren County Water and Sewer Department relative to small diameter water lines in rural areas.

Upon motion the meeting was adjourned.

Aquifer Preservation Subdistrict Warren County

Summary Report 2012-2019

Purpose

The purpose of the Aquifer Preservation Subdistrict (APS) is to develop and maintain an ongoing, watershed-wide program in support of comprehensive protection, management, and understanding of the region's water resources.

Water Stewardship

MCD works to help protect and improve water for people living and working within the Great Miami River Watershed—a 3,946-square-mile area in southwest Ohio. Using data collected by our staff and partners, we work collaboratively with elected officials and community leaders providing them with valued research and insight. This helps support the overall health and growth of our region. This work is funded by MCD's Aquifer Preservation Subdistrict.

In addition to the activities and programs summarized in MCD's Water Stewardship Summary Report for 2012-2019, here are highlights from activities conducted in Warren County:

- **Investigated high levels of nitrate and arsenic** in the aquifer that could be deadly for certain populations.
- Helped to protect families' health by providing private well owners with free water testing at "Test Your Well" events.
- **Protected groundwater resources** by providing the Warren County Health Department with materials to help rural homeowners **properly maintain their septic systems**.
- Promoted experiential water education by sponsoring the University of Dayton's
 Rivermobile, a mobile learning studio created and managed by students from the Rivers
 Institute. The Rivermobile attended Warren County Schools.
- Funded land acquisition in the Village of Carlisle to help protect groundwater.
- Facilitated a coalition of wastewater facilities to **study and understand nutrient conditions** in the Great Miami River.
- **Funded an interactive groundwater classroom tool** for Warren Soil and Water Conservation District. The model depicts the flow of water and how pollution can travel through the aquifer.
- Sponsored the Warren Soil and Water Conservation District's Water Trailer to promote knowledge of water and hands-on education.
- Educated managers of green spaces, such as parks and golf courses, about groundwater-friendly practices, and encouraged them to implement these practices.
 Supported community-based organizations and decision-makers throughout Warren County who work to address local water resource issues.
- Promoted understanding of water resource challenges by providing assistance and
 expertise at the Area IV Envirothon, a competitive, academic, outdoor team event for
 high school students.
- Sponsored clean-up of the Great Miami River. Annual volunteer clean-up events help citizens take pride in the beautiful rivers we share.

Funding

Funds to operate APS water stewardship programs are generated by assessments paid by nine counties: Butler, Clark, Greene, Hamilton, Miami, Montgomery, Preble, Shelby, and Warren. APS supplements assessment funding, when possible, with local, state and federal grants.

Warren County's annual APS assessment is: \$47,854. This assessment has remained the same since 2005. No changes to the annual assessment will occur in 2020. MCD will re-evaluate funding needs in 2021 and will notify the county if there are proposed changes at that time.

Income, assets, costs, and obligations of APS are separate from MCD's flood protection system and other MCD subdistricts.

Looking Ahead

This region boasts abundant, high-quality water when compared to other parts of the country and the world. Yet, our water supply is vulnerable and could be threatened. Water here and across the United States faces multiple threats from changing weather patterns, polluted runoff from land, and our own personal actions. Understanding water conditions in rivers, streams, and groundwater; and encouraging stewardship of our water is crucial to protecting health and quality of life. Clean water is essential for human health and economic vitality.

Program Reauthorization

The APS activities are directed by an Official Plan. The Official Plan states that a comprehensive summary of all work performed will be presented to the elected body of each participating county every eight years. A revised budget and assessment schedule will be provided if there are proposed changes. The Official Plan was approved in 1996, and reauthorized in 2004 and 2012. The MCD Board of Directors and Conservancy Court will accept input from each participating county and consider reauthorization of the program during 2020.
