DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

The Board discussed various draft resolutions that were presented for discussion relative to Covid-19 pandemic:

1. Ratify Essential Personnel Plan --- The Board approved.

2. Authorize County Administrator, during disaster, to approve purchases up to \$100,000, sign final plats, provide letters to jail contractor to declare jail as essential infrastructure project.

Bruce McGary, Assistant Prosecutor, explained the requirement under O.R.C. 307.81 for the Board to declare a clear and present emergency in order to authorize expenditure without competitive bidding under \$100,000. He stated that under the declaration of the Governor's Order, this resolution would follow those requirements and authorize the County Administrator or Deputy County Administrator, in her absence, to approve contracts, etc. and in addition, to sign final plats as requested by the Homebuilder's Association, as well as issue a letter as requested by Grainger Construction.

Mrs. Zindel discussed the capital purchase requisitions that the Board typically approves by signature.

There was discussion relative to the process the Board desires: approve the County Administrator to approve the requisitions they typically sign or approve by resolution on the consent agenda

Commissioner Young stated his desire for the individual items to be read aloud each week for the Board's approval and County Administrator's signature.

Upon further discussion, the Board resolved (Resolution #20-0501) to approve the capital purchase requisitions and authorize County Administrator to sign documents relative thereto.

3. Authorize Warren County Emergency Management Agency Director to apply for and/or assist other Warren County agencies and/or political subdivisions with requesting any and all State and Federal assistance necessary to assist with the COVID-19 pandemic.

Mrs. Zindel stated that this resolution is in follow-up to the declaration of emergency resolution that was discussed at the last meeting. This proposed resolution was drafted by the Prosecutor's Office and amended by Commissioner Grossmann.

There was discussion with the Assistant Prosecutor relative to the necessity of this resolution but this resolution was circulated and created by the County Commissioners' Association of Ohio providing clarification of the authority of Emergency Management to apply and/or assist other jurisdictions in Warren County.

Upon further discussion, the Board resolved (Resolution #20-0502) to authorize Warren County Emergency Management Agency Director to apply for and/or assist other Warren County agencies and/or political subdivisions with requesting any and all State and Federal assistance necessary to assist with the COVID-19 pandemic.

Commissioner Young discussed the diligent work of staff during this time of emergency and requested the County Administrator to provide an update.

County Administrator Tiffany Zindel stated that the county is purchasing personal protective equipment (PPE) at every opportunity that is being presented. She then stated that some vendors do not allow the purchase order option and require a credit card for purchase. She stated that the county credit card limit is in process of being increased and personally thanked Commissioner Young for the use of his personal credit card as well our community partners and Emergency Services personnel for their tireless efforts to protect our community.

Mrs. Zindel then stated that they are working on the creation of a formula to distribute the PPE's to local jurisdictions as they are acquired.

Bruce McGary, Assistant Prosecutor, discussed the recently amended Ohio Department of Health's order reducing the mass gathering limit from 50 people to ten. He then presented a resolution for consideration which amends the previously adopted prohibition of mass gatherings in County buildings from 50 to 10 in compliance with the amended order.

There was discussion relative to the courts as it relates to the Judge's Orders relative to essential court function along with the court order that the Common Pleas Court provided relative to the limitations they are implementing relative to hearings.

There was discussion relative to the County Court process as it related to the current situation as the parking lot was full this morning.

Upon discussion, the Board requested that County Administrator Zindel follow-up with County Court on how they are currently conducting hearings as it relates to the Covid-19 pandemic.

Upon further discussion, the Board adopted Resolution #20-0503 to amend Resolution #20-0462, in part, by prohibiting any gathering of more than ten (10) people in the Warren County Administration Building or any other County owned or operated buildings and facilities unless excepted herein or otherwise exempted by the Ohio Department of Health's Stay at Home Order.

There was further discussion relative to the resolution discussed earlier relative to authorizing the County Administrator, during disaster, to approve purchases up to \$100,000 including approving contracts, signing of final plats, and providing a letter to the jail contractor to declare the jail construction as an essential infrastructure project.

Tina Osborne, Clerk of Commissions, stated she did not hear a vote relative to that resolution but rather, the Board approved a resolution authorizing the County Administrator to approve the listed capital purchase requisitions.

Upon discussion, the Board approved (Resolution #20-0504) finding a real and present emergency exists during the COVID-19 pandemic and amending Resolutions #10-0948 and #16-

1936, in part, for the purpose of authorizing the County Administrator to perform, in the Board's absence, specific functions conferred or incumbent upon the Board.
