Madeline Iseli, Sinclair Community College Senior VP for Advancement and Regional Strategies, was present along with representatives from Sinclair Courseview Campus, for the presentation of the Warren County Scholarship check in the amount of \$56,200 to be used towards tuition for Warren County residents attending the Courseview Campus.

Ms. Iseli introduced the Sinclair Community College Board members and staff present in today's meeting and presented the attached PowerPoint presentation for 2019-2020 which included an update for the Courseview Campus including the Strategic Planning currently underway and an update on enrollment and graduation rates.

Ms. Iseli stated that the total scholarships awarded since 2007 is \$590,041 which includes awards for 5627 students.

Mr. Schnipke presented the attached PowerPoint slide outlining the program and the proposed fund disbursement.

Mr. Schnipke then reviewed the amended requirements relative to the application process.

Commissioner Young exited the meeting at 12:10 p.m.








Sinclair College Credit Students by County of Residency

Unduplicated Headcount Students FY2020




Sinclair Credentials Earned by Warren County Residents




Sinclair Student Enrollment for Warren County Residents

Top 5 Largest Growth Zip Codes (as of August 5, 80% through on-time registration)









Warren County High School Graduates **Enrolling at Sinclair**

Dual Enrolled Warren County Number of Credit Hours Earned by Year **High School Students**




