On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

James Kuhn, Patient Advocate/Navigator with the Foundation for Sarcoidosis Research and Morrow resident was present to present information on Sarcoidosis and the need to bring awareness of this rare systemic inflammatory disease.

Upon discussion, the Board presented a proclamation to Mr. Kuhn proclaiming April as "Sarcoidosis Awareness Month" in Warren County.

Nolan Cook, Chief Mechanic, was present to discuss the request of the City of Franklin to provide mechanical services to their law enforcement vehicles.

Mr. Cook stated he has been in discussion with the Prosecutor's Office relative to this request and was instructed to complete a cost analysis in order to establish a rate for services. He stated that the current rate is \$55 per hour which was established in 2016, but upon completion of the analysis, the cost should be \$86 per hour.

There was discussion relative to the capacity at the garage and the ability to add additional work.

Mr. Cook stated that the City has approximately 30 cars which should not be a problem. He then clarified that county vehicles would take priority over outside entities.

There was discussion relative to the need for a uniform rate as well as the gradual increase to allow notice to the entities utilizing the garage.

There was discussion relative to the desire to not be in competition with the private sector but understanding the need for service for these specialized police vehicles.

Upon discussion, the Board agreed to increase the rate gradually with the full increase taking effect with next year budgets. They also stated the need to complete cost analysis more frequently rather than waiting six years.

Matt Schnipke, Economic Development Director, was present to discuss the ARPA funded broadband project.

Mr. Schnipke reviewed the discussion from the last work session relative to the Board's desire and direction to work with a consultant to help write a proposal which would partner the County ARPA funds with the private provided funds.

Mr. Schnipke stated he has been in discussion with various firms and Morley was the only response to the solicitation for a consultant.

Commissioner Young pointed out the risk of committing ARPA funding when the funds from the budget bill could fund this project and those funds could be used for something else.

Upon further discussion, the Board resolved (Resolution #22-0548) to authorize the County Administrator to negotiate agreement toward broadband related professional services utilizing ARPA (American Rescue Plan Act) funds.

Commissioner Jones acknowledged April as "County Government Month" and requested a picture with the Board in front of the Administration Building holding the County Commissioners Association of Ohio County Government Month sign.

Upon motion the meeting was adjourned.
