On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Andrea Ostrowski, attorney and representative of the Warren County Bar Association, was present for a work session along with representatives from Warren County Common Pleas Court to discuss the indigent defense fee schedule.

Ms. Ostrowski stated she had originally requested the fee increase to the Board in 2020, however, a decision was never made. She stated that the rates have not increased since 2000, and that the Ohio Public Defender's Office currently reimburses the County at 90%. She then presented the attached information and requested the Board increase the rate to \$75/ hour Countywide for both in and out of court time, as well as increase the maximum allowable compensation.

There was discussion relative to the maximum allowable compensation under the current fee schedule.

Judge Oda stated that the maximum allowable amounts are more important to Judge Kirby than the Criminal Division. He believes the maximum amounts are an average to what a trial should cost. Judge Oda stated the concern in raising the maximum allowable amounts should be the tipping point for the price paid for defense.

Commissioner Jones and Commissioner Young agreed they would like Commissioner Grossmann to be present to express his opinion on increasing the maximum allowable amounts.

Prosecutor David Fornshell stated he was in support of increasing the hourly rate to \$75/ hour but did not feel it was appropriate for him to weigh in on the maximum allowable amount.

County Auditor Matt Nolan requested the hourly rate of \$75/hour be across the Board Countywide.

Upon further discussion, the Board resolved (Resolution #22-0726) to amend Warren County assigned counsel fee schedule to increase the hourly rate for time in and out of court to \$75 per hour effective June 1, 2022.

Michelle Tegtmeier, Director of the Warren County Building and Zoning Department, was present for a work to discuss amending the fee schedule within the Warren County Building and Zoning Department as well as the purchase of software for the building inspectors.

Ms. Tegtmeier discussed the need for software to use the tablets purchased a year and half ago to be used within the Building and Zoning Department. She stated a private company, IWORQ Systems, provides many local jurisdictions with the software needed to run the tablets. She requested to enter an agreement with IWORQ Systems.

Upon discussion, the Board resolved (Resolution #22-0727) to approve the software agreement with IWORQ Systems, Inc. on behalf of the Warren County Building and Zoning Department.

Ms. Tegtmeier then presented the proposed changes to the current fee schedule within the Building and Zoning Department and requested the Board to schedule a public hearing to consider the proposed changes.

Upon discussion, the Board resolved (Resolution #22-0728) to set the public hearing to consider amendments to the fee schedule to consider increases and additional classifications within the Warren County Building and Zoning Department.

Upon motion the meeting was adjourned.

RE:

Indigent Defense Reimbursement Rate Periodic Update

I write today with a periodic update on the indigent defense reimbursement rate. As shared in our prior memorandums, Governor DeWine and the Ohio General Assembly allocated approximately \$336 million dollars in the Biennial State Budget to reimburse counties for indigent defense costs for Fiscal Year 2022 and 2023 (July 1, 2021 – June 30, 2023). This level of funding for indigent defense is unprecedented in Ohio. In July 2021, the OPD estimated that the allocated funding would permit the state to reimburse counties at a reimbursement rate approaching 100%, based on projected reimbursement submissions of \$13mil/per month in FY22 and \$13.5mil/per month in FY23. As we approach FY23, county submissions are exceeding projections.

The OPD is committed to keeping all system parties and stakeholders apprised of the reimbursement rate throughout the fiscal year with periodic updates on the total costs submitted and remaining appropriated funds. The OPD has thus far processed nine months of regular reimbursement submissions in Fiscal Year 2022 (May 2021 – April 2022 reimbursement submissions are processed during July 2021 – June 2022), in addition to extension submissions¹ (for those counties that have elected to utilize the extension option) that were available earlier this fiscal year. All payments were made with a reimbursement rate of 100%.

The OPD will continue to monitor changes to appointed counsel and public defender submissions but taking into account the submissions received thus far during FY22, the OPD continues to project a reimbursement rate approaching 100% for FY22.

It is important to note that some counties are in the process of increasing appointed counsel rates, increasing public defender salaries, and funding necessary public defender facility expenses. Those increases in spending are in excess of any projections and well beyond the normal projected growth rates. While all of these improvements are vitally needed and supported by the OPD as necessary expenditures, these overdue system improvements are occurring in one fiscal cycle. The OPD's best

¹ In response to the COVID-19 pandemic, the OPD made several options available to counties to provide support and assistance with their reimbursement submissions during the pandemic. One of those options was an extension process whereby counties could have an additional 60 days to submit indigent defense expenses for reimbursement. The extension provision ended with the month of October 2021 and any extensions for that month were due by the end of December 2021.

estimate at this juncture is the reimbursement rate for FY23 will approach 90%. This estimate is certainly subject to change based on the respective expenditures and reimbursement submissions from all 88 counties. We will keep you apprised of any updates via future periodic updates.

The General Division Judges (Oda, Peeler & Tepe) met this morning and voted unanimously to recommend to the County Commissioners the adoption of a raise for court appointed attorney fees. Our recommendation applies to both the hourly rate and the maximum fee schedule for felony, misdemeanor and appellate cases in connection with the Criminal Division of the Common Pleas Court. We make no recommendations with regard to county court, probate court, juvenile court or domestic relations court.

While the judges are mindful of remaining a good steward of taxpayer dollars, we believe this pay raise is in the best interest of the County. I have said many times before that the attorneys who serve on our court appointment list provide the Warren County taxpayers, by far, the best value for their dollar – even with this proposed raise. This fee schedule is in line with surrounding counties and the recommendations made by the Ohio Public Defender's office. At the current rate of reimbursement by the State, this should have zero impact on our budget (we are currently being reimbursed at 100%). However, this reimbursement rate is subject to change at the discretion of the Ohio Public Defender.

I have attached our proposal for your review in advance of the meeting next week. I have also attached the old fee schedule, adopted over 20 years ago, for your reference.

Warren County: Last revision 2000, except for new mandatory rate for capital cases adopted 10/26/21. Current rate

\$60.00 in court, \$50.00 out of court

Butler County: adopted OPD max fee schedule - Hourly rate \$75.00 in and out of court.

Clinton County: last fees updated 2019 - Hourly rate \$75.00 in and out of court **Hamilton County:** adopted OPD max fee schedule - \$75.00 in and out of court

Montgomery County: adopted OPD max fee schedule - Hourly rate \$75.00 in and out of court Franklin County: adopted OPD max fee schedule - Hourly rate \$75.00 in and out of court

SECTION II

STATE MAXIMUM FEE SCHEDULE FOR APPOINTED COUNSEL REIMBURSEMENT

A. General provisions

- The Ohio Public Defender State Maximum Fee Schedule for Appointed Counsel Reimbursement contains the hourly rates and maximum amounts the OPD will reimburse counties for representation of indigent persons in criminal cases.
- 2. Pursuant to R.C. 120.33(A)(3), to receive reimbursement, a board of county commissioners must adopt a resolution to pay counsel appointed by the court, and must establish a fee schedule. The county is responsible for filing an up-to-date fee schedule with the OPD. Reimbursement will be based on the latest fee schedule filed with the OPD.
- 3. Reimbursement to the counties shall be based on the most serious offense with which the defendant is charged and will be made at up to 100 percent of either the State or county rate, whichever is lower. Reimbursement shall not exceed the established hourly or maximum rates unless otherwise provided for by statute.

B. Trial Level Proceedings

- Reimbursement for representation in trial level cases not involving a death penalty specification will be made based on the maximum rate of \$75.00 per hour for both in-court and out-of-court services.
- Reimbursement for representation in trial level cases involving a death penalty specification will be made based on the maximum rate of \$125.00 per hour for both in-court and out-of-court services.

C. Juvenile proceedings

- Reimbursement for representation in juvenile proceedings will be made based on the maximum rate of \$75.00 per hour for both in-court and out-of-court services.
- 2. Reimbursement will not be made for non-attorneys appointed as a guardian ad litem.
- In abuse, dependency, and neglect cases, both the attorney and the guardian ad litem may bill up to the maximum fee allowed by the county for the initial dispositional hearing and each subsequent annual review hearing before the court.
