PUBLIC HEARING

CONSIDER MODIFICATIONS TO THE FEE SCHEDULES WITHIN THE WARREN COUNTY BUILDING AND ZONING DEPARTMENT

The public hearing to consider modifications to the fee schedules within the Warren County Building and Zoning Department was convened this 21st day of June 2022, in the Commissioners' Meeting Room.

Commissioner Grossmann opened the hearing by stating this is a second public hearing to allow for public discussion relative to the modifications proposed to the fee schedules.

There being no one present to speak about the modifications, on motion, the public hearing was closed, and the Board resolved (Resolution #22-0931) to adopted to approve modification to the fee schedules within the Warren County Building and Zoning Department.

Gary Estes, Telecommunications Deputy Director, was present for a work session to present the Service and Product Utilization Report for 2021.

Mr. Estes presented the attached report which shows the data on spending relative to radios by community.

There was discussion on whether the report includes dispatch in the data.

Mr. Estes clarified that it does include the technology costs but not the labor.

There was discussion relative to the report and the desire to include data that shows the cost savings to the communities with having Warren County provide dispatch versus having their own.

There was discussion relative to a manual being prepared as well as the desire of the Board for the executives of political subdivisions to understand the services provided by Warren County.

Commissioner Jones thanked them for the report.

Tiffany Zindel, County Administrator, discussed the possibility of a memorandum of understanding with the political subdivisions which would spell out exactly what services are provided by Warren County.

On motion, upon unanimous call of the roll, the Board entered into executive session at 9:23 a.m. to discuss hiring and compensation within Children Services pursuant to Ohio Revised Code Section 121.22 (G)(1) and pending litigation to consult with an attorney who is present pursuant to Ohio Revised Code Section 121.22 (G)(3) and exited at 11:20 a.m.




SPUR Service + Product Utilization Report

Categorized by Warren County Community for year ending 2021

The SPUR illustrates the quantifiable Telecom products & services utilized by each Warren County community, combining police, fire, EMS, school, administration, and public works data. In addition to this SPUR, Telecom distributes a Benefits Assessment Report (BAR) to each Fire/EMS, Law Enforcement, Probation agency plus Emergency Services. The goal is to reconcile inventories, rosters, reduce unnecessary spending, and communicate the spend-share.

- The pie chart on each community's page illustrates Commissioner-funded components.
 A partner's Benefit Assessment Report digs deeper into ownership splits and itemized rosters.
- There are more pieces to the pie that we have not yet quantified. Several systems are hard to divide fairly between the communities. Rather than misrepresenting figures, we're opting not to include.
- Some communities share the same resource; e.g. Salem Twp and the Village of Morrow both use Salem-Morrow Fire/EMS. For that reason, some agency counts are applied to more than one community. Do not attempt summing up the blue figures from each Community's page... that would overinflate the total BOCC contribution.
- South Lebanon & Deerfield Twp figures are lower than reality because many databases don't break out the (3)
 Sheriff's Office Posts.



Based on compiled data as of December 31, 2021, the Warren County Board of Commissioners funds various Telecommunications products and services for the communities of Warren County.

These are not all dollars spent in 2021. Rather, it's the total value of current products & services utilized within the communities... radios, fire pagers, HipLink mobile messaging licenses, mobile data computers and their operating systems / licenses, modems, cell phones, desk phones, records management systems, etc.















































OF PERSONS TRAINED BY AGENCY





RADIOS BY COMMUNITY OR WARREN COUNTY DEPARTMENT





This chart shows how many Fire Pagers are accounted for in each community. Public Safety agencies are provided Commissioner-funded Minitor pagers per the Radio Distribution Policy. Several departments have also purchased additional pagers with their own funds.

To accurately depict the citizens receiving the benefit of these devices, agency's fire pagers are applied to the primary communities they serve and may show up in more than (1) count: e.g. Wayne Twp's Pagers were applied to both Wayne Twp and Waynesville tallies.



This chart shows how many Emergency Messaging / Hiplink licenses are accounted for in each community. Hiplink allows users to receive real-time notifications for Public Safety Incidents, system alerts, and page-outs. Receivers include public safety, administrators, school officials, county coworkers, mutual aid partners.





This chart shows how many mobile data computers are accounted for in each community. Most agencies pay for their computer/tablet and cellular connectivity devices.

This chart shows how many modems / cellular connectivity devices are accounted for in each community.

Agencies use these to maintain Verizon connectivity to their MDCs, tablets, and phones to interact with dispatched calls, reporting systems, LEADS, etc.
